RE: Termination of Cleveland Clinic

Dear Valued First Health Client:

This communication is an update to our previous May 19, 2025 communication that advised you that Cleveland Clinic's participation in the First Health networks will terminate effective July 1, 2025. This updated letter is being provided to you because there are additional Cleveland Clinic providers in the state of Florida that were not previously provided. This termination is applicable to facility, ancillary and employed physician services for dates of service on or after July 1, 2025.

- Cleveland Clinic will be out-of-network effective on July 1, 2025.
- We will continue to offer our members in-network access to their hospitals and providers through June 30, 2025.
- We understand the importance of providing members with access to affordable care that is local, simple and helps achieve better health. We have a network of health care providers that can meet the vast majority of our members' health care needs in the communities where they operate.
